2025 Small Business 2026 Tax Calendar

Monthly Activity Statement Due Dates:

 The 21st of each month is the due date to lodge and pay monthly activity statements for the previous month. If the 21st falls on a Saturday or Sunday, the due date is the following Monday.

1 July 2025:

- Start of the 2025–2026 financial year.
- 1 July to 31 October Tax season for individuals and small businesses.

14 July 2025:

 Employers must finalise and submit Single Touch Payroll (STP) data for the 2023–2025 financial year.

28 July 2025:

- Quarterly Business Activity Statement (BAS) due for the April–June 2025 period.
- Superannuation Guarantee (SG) contributions due for the April–June 2025 quarter.

25 August 2025:

 Quarterly BAS due for the April-June 2025 period if lodged by a BAS agent.

28 August 2025:

 Taxable Payments Annual Report (TPAR) due for businesses in certain industries.

28 October 2025:

- Quarterly BAS due for the July-September 2025 period.
- SG contributions due for the July–September 2025 quarter.

31 October 2025:

 Income tax due for large and medium companies and super funds.

25 November 2025:

 Quarterly BAS due for the July-September 2025 period for businesses lodging electronically if lodged by a BAS agent.

28 January 2026:

 SG contributions due for the October–December 2025 quarter.

28 February 2026:

Quarterly BAS due for the October–December 2025 period.

28 April 2026:

- Quarterly BAS due for the January–March 2026 period.
- SG contributions due for the January–March 2026 quarter.

15 May 2026:

 Income tax return due for individuals and businesses using a registered tax agent.

21 May 2026:

• Due date to lodge the Fringe Benefits Tax (FBT) return.

26 May 2026:

 Quarterly BAS due for the January-March 2026 period if lodged by a BAS agent

30 June 2026:

• End of the 2025–2025 financial year.
